Extortion and Mischief Charges to be filed

Today, at the request of a home builder frustrated with site blockages and demands for money by native protesters CANACE co-founders gathered video and other evidence they believe warrant the laying of criminal charges against Ruby and Floyd Montour on charges of Extortion and Mischief for their role in blocking the Cayuga, Ontario development site.

After signing a CANACE form authorizing the gathering of evidence for use in laying criminal charges, we videotaped the legal owner of the construction site asking Ms. Montour and her group to leave. Upon refusing to leave, the legal owner requested the OPP to lay criminal charges.

Due to the OPP's refusal to enforce the criminal code of Canada and their refusal to acknowledge the legitimacy of Supreme Court rulings, CANACE will be filing criminal charges as stated above via 'Private Prosecutions.'

Any builder in Haldimand, Brant or Hamilton-Wentworth who has been approached by Ruby or Floyd Montour in an attempt to stop construction or to demand payment in return for an end to blockades or occupations, are asked to contact CANACE immediately so additional evidence can be gathered for the purpose of laying additional charges.

CANACE is currently gathering evidence to lay Extortion charges against each member of HDI, the group that some builders and politicians claim operate like the Mafia. Any builder who has had a meeting with HDI and is willing to make a signed statement as to potentially illegal demands is asked to contact CANACE. A video statement would be very helpful in laying charges.

The Government of Ontario has told the public that HDI has no legal right to collect fees and that builders should seek their own solution. CANACE has decided to play a role in providing that solution.
