OPP Race Based Policing confirmed in Caledonia Again - May 24, 2009

These brave OPP officers you see in the photo above have been sold a lie that Native Protesters have the legal right to control the Charter Rights of all other citizens in Ontario. Can you imagine that in the 21st. century we still have racist police policies that repeatedly allow officers, with complete encouragement by senior officers, to violate the rights of a whole race of people solely because one group is willing to be violent.

You would think that Canadians would have learned from the evils of Southern USA where white radicals (the KKK) believed they had the right to use violence to protect their culture against Black people. The police in the South as well as many politicians backed the rights of the KKK to force Black people into submission.

In Ontario we now have the exact same thing. The McGuinty Government fully supports the use of OPP resources to limit the rights of non-Native people to appease Native Protesters. The OPP knows full well that Native Protesters have repeatedly used violence to force their political agenda upon the Government, which is the very definition of Terrorism in Canada. However, instead of arresting those who commit terrorist acts in Ontario the OPP use their resources to appease the Terrorists by forcing non-Natives to submit to the will of Native Protesters.

In Haldimand County the OPP has become the enforcement arm of Native Protesters. It now only takes 2-3 Native Protesters to show up to shut down a construction site because the OPP will immediately move in to force all non-Natives to comply with Native Protesters. It is the OPP who directly threaten to arrest the legal owners of properties instead of threatening to arrest Native Protesters. It is the OPP who block and turn away construction vehicles. It is the OPP who force the legal owners of these properties to stop construction and leave the area.

The Crown's Office in Cayuga has repeatedly ran interference to protect the OPP who commit illegal acts. The Crown directly interferes with the laying of criminal charges against OPP officers and when judges finally order OPP officers to be charged the Crown quickly steps in to stay the charges.

The Justice System in Haldimand is completely corrupted by Racist Policies which are designed to appease the radical Native Protesters who have demonstrated that violence in Ontario does pay.

Just a small sample of crimes committed by Native Protesters who have never faced any charges for these acts.

The burning down of the Stirling Bridge in full view of OPP officers. At the time Native Protesters stopped emergency vehicles from responding. Mayor Trainer testified in Nov. 2008 that at the time Native Protesters threatened to shoot firemen who responded. She told the court that OPP officers immediately drove away from the scene as soon as the threats were issued.

Three years after all these crimes the OPP have refused to lay any charges.



Stirling Bridge - no arrest after 3 years

The OPP refused to provide any protection to the local power substation which was finally attacked by driving a truck into the station and setting it on fire. Later Hydro One was forced to provide their own security because the OPP continued to refuse to protect the station. One day Native Protesters swarmed the security car and forced the security person to flee. The car was then set on fire.

Three years after all these crimes the OPP have refused to lay any charges.



Security Car - no arrest after 3 years

For six weeks Native Protesters blocked the main highway in Caledonia with a stolen hydro tower. The Native Protesters created many tire fires in the middle of various roads around Caledonia as well as roamed the town carrying weapons while being masked. Residents were forced by the Native Protesters to carry 'passports' issued by these thugs to allow them to travel down this highway. Native Protesters daily enforced their will on all traffic in plain view of the OPP and stopped and searched all vehicles.

Three years after all these crimes the OPP have refused to lay any charges.



Block highway for six week - no arrest after 3 years

In Haldimand under a McGuinty Government the OPP wilfully violate the Rights of non-Natives they also aid in the criminal acts of Native Protesters.

Randy continues to walk down the road with no one near him.



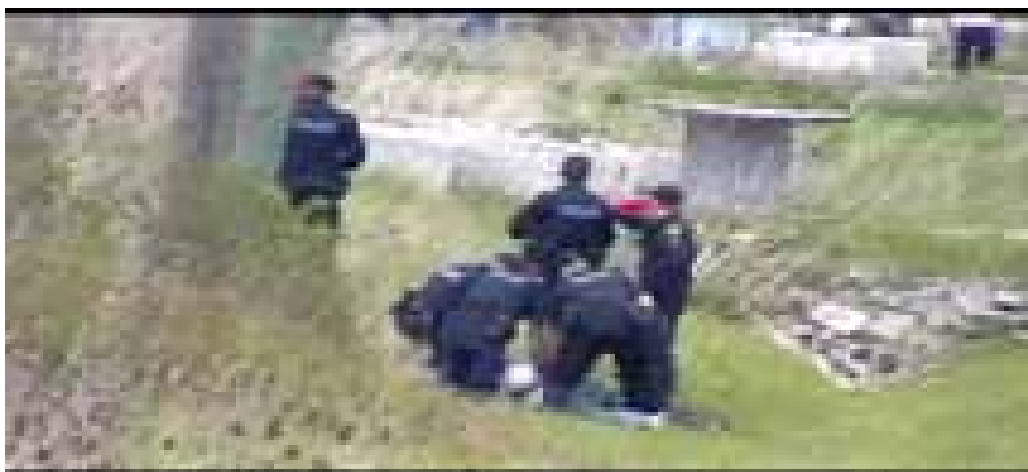
Randy then calmly walks down towards Provincially owned land called Douglas Creek Estates which the taxpayers have paid approx. \$22 million to purchase.

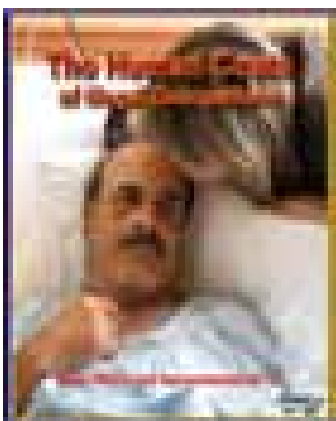

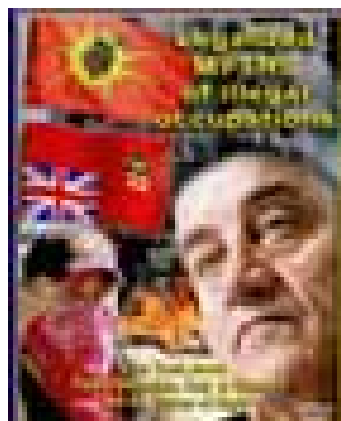
