Re: Shawn Brant violates Canada's Anti-Terrorism Act

Dear Stockwell Day:

As head of Public safety it is incumbent upon you to ensure that direct terrorist threats against Canada not be allowed to go unaddressed.

A few weeks ago I exposed a YouTube video that was training people how to sabotage the rail lines across Canada in support of Native Land Claims. I forwarded this video to CSIS and CN Police and was in contact with CN Police about 6 times.

Earlier this week I released a video regarding a speech given by Shawn Brant, Native protester in Deseronto, which he gave in Toronto in mid-May.

In this speech Mr. Brant clearly states, "I don't give a rat's ass whether I create victims or what the white man thinks of me..." He continues to clearly state that railway lines, hydro lines, gas lines and highways are to be targeted. He states, "not until every home has suffered like we have suffered will I stop". He states that he has been going around from Native community to Native community with the same message. That message includes Natives taking up guns, and the attack upon the infrastructures already listed.

Mr. Brant has been arrested several times over the years for his violent actions against elected officials and against property. He is currently charged for issuing death threats against military personnel back in December.

Mr. Brant's words and actions are a clear violation of Canada's Anti-Terrorism Act. Why has your department refused to act to protect the public? If Mr. Brant was a Muslim your department would have arrested him on terrorist charges months ago.

The direct appeasement by the Harper Government to offer \$125 Million to help stop the Native National Day of protest set for June 29th is a violation of everything a Conservative Government that states it believes in Law & Order should stand for.

It is one thing to have the complete failure of the OPP to stop the assault upon a camera crew, the attack upon seniors and the attempted murder of an OPP officer, but quite another for the Federal Government to continue to permit a direct terrorist threat to this country.

Just yesterday the Native Protesters in Deseronto once again confronted OPP officers. Does someone have to die before your office will act? Must this country experience a terrorist attack before you will take action?

The Americans experienced 911 and everyone now talks about how things could have been done to possibly prevent 911. Police agencies could have shared information or arrested a few people who were clearly planning things.

Must Canada experience the same before the Federal Government takes the necessary steps to prevent destruction and maybe death?

This is serious and the time for political games is over. I expect that your office will deal with this issue immediately. Please have someone call me ASAP to ensure that your office is in fact serious about Public Safety.
